



## Methodology

Third Inter-American Meeting of Experts and Representatives of Electoral Bodies of the Member Countries of the Organization of American States (OAS)

"Approach towards a Reference Framework of common criteria and optimal procedures for electoral processes management and control".

Caracas, Thursday 29 and Friday 30 of July 2010

To this end, participants are expected to debate and discuss about the core topics based on the inputs drawn during the  $2^{nd}$  Inter-American Meeting (June 2009). For the sake of order and efficiency in processing data, participants will input the information in a double-entry table. The left column will show the specific procedures of each core process defined and the top row will provide for the criteria identified during the  $2^{nd}$  Meeting.

The table inputs will be produced out of a driving question that allows for cross matching each procedure with the respective criterion.

How to guarantee common criteria in each procedure identified for the core electoral processes?

This could be represented by a specific question connected to the "Voting, Counting and Tally-up" electoral processes.

## **Working Dynamics**

With the aim of optimizing time for debate, the discussion will be carried out in two Working Groups (A and B) that will exchange their viewpoints about each topic.

Each Working Group will be made up by 20 – 30 people roughly, one (1) Coordinator, appointed among the CNE Directors with expertise in each topic; two (2) rapporteurs in charge of organizing the information and one (1) Moderator in charge of the speakers list and time keeping. Each Working group will have 45 minutes to discuss about each of the ten topics. The groups have been integrated in a balanced manner so as to guarantee the participation of the experts in the discussions.

In this regard, PARTICIPANTS ARE NOT EXPECTED TO DELIVER SPEECHES OR PRESENTATIONS DURING THE DISCUSSION, but to contribute to filling out the table for each topic.

It is worth highlighting that at the end of each discussion; the rapporteur will meet and discuss the conclusions drawn out of each working group with the CNE methodological coordination team.
